CONSTRUCTION OF CLEAN WATER SUPPLY SYSTEMS, HYGIENE EDUCATION AND LATRINE CONSTRUCTION. CONTAMINATED WATER IS RESPONSIBLE FOR A MYRIAD OF HEALTH PROBLEMS INCLUDING TYPHOID, CHOLERA AND PARASITIC INFECTIONS. WOMEN AND CHILDREN WALK MILES EACH WAY CARRYING HEAVY CONTAINERS OF WATER. GATHERING JUST 20 LITERS OF WATER CAN TAKE UP TO NINE HOURS A DAY; THIS AMOUNT IS ONLY SUFFICIENT FOR ONE HOUSEHOLD FOR TWO DAYS AND JUST FOR COOKING FOOD. REDUCING THE AMOUNT OF WORK THAT WOMEN HAVE TO DEVOTE TO WATER COLLECTION IMPROVES THE ECONOMIC SITUATION BY GIVING THEM TIME TO USE FOR OTHER MORE ECONOMICALLY USEFUL PURPOSES. HYGIENE EDUCATION TEACHES PEOPLE TO AVOID DISEASES THAT CURRENTLY FLOURISH BECAUSE OF LACK OF CLEAN WATER.

HER GRADUATION FROM SECONDARY SCHOOL IS A VICTORY IN THE FACE OF OVERWHELMING ODDS.
